
Euro area bank interest rate statistics: November 2024

- Composite cost-of-borrowing indicator for <u>new loans to corporations</u> decreased by 15 basis points to 4.52%; indicator for <u>new loans to households for house purchase</u> decreased by 8 basis points to 3.47%
- Composite interest rate for <u>new deposits with agreed maturity from corporations</u> decreased by 17 basis points to 2.89%; interest rate for <u>overnight deposits from corporations</u> broadly unchanged at 0.81%
- Composite interest rate for <u>new deposits with agreed maturity from households</u> decreased by 12 basis points to 2.61%; interest rate for <u>overnight deposits from households</u> broadly unchanged at 0.35%

Data for cost of borrowing and deposit interest rates for corporations (Chart 1)

The composite cost-of-borrowing indicator, which combines interest rates on all loans to corporations, decreased in November 2024. The interest rate on new loans of over $\in 1$ million with a floating rate and an initial rate fixation period of up to three months decreased by 22 basis points to 4.42%. The rate on new loans of the same size with an initial rate fixation period of over three months and up to one year fell by 10 basis points to 4.19%. The interest rate on new loans of over $\in 1$ million with an initial rate fixation period of over three months and up to one year fell by 10 basis points to 4.19%. The interest rate on new loans of over $\in 1$ million with an initial rate fixation period of over ten years decreased by 11 basis points to 3.48%. In the case of new loans of up to $\notin 250,000$ with a floating rate and an initial rate fixation period of up to three months, the average rate charged stayed almost constant at 4.80%.

As regards new deposit agreements, the interest rate on deposits from corporations with an agreed maturity of up to one year fell by 16 basis points to 2.90% in November 2024. The interest rate on overnight deposits from corporations stayed almost constant at 0.81%.

The interest rate on new loans to sole proprietors and unincorporated partnerships with a floating rate and an initial rate fixation period of up to one year remained broadly unchanged at 4.92%.



Data for cost of borrowing and deposit interest rate for households (Chart 2)

The composite cost-of-borrowing indicator, which combines interest rates on all loans to households for house purchase, decreased in November 2024. The interest rate on loans for house purchase with a floating rate and an initial rate fixation period of up to one year decreased by 10 basis points to 4.27%. The rate on housing loans with an initial rate fixation period of over one and up to five years fell by 7 basis points to 3.62%. The interest rate on loans for house purchase with an initial rate fixation period of over one and up to five years fell by 7 basis points to 3.62%. The interest rate on loans for house purchase with an initial rate fixation period of over five and up to ten years decreased by 4 basis points to 3.43%. The rate on housing loans with an initial rate fixation period of over ten years fell by 6 basis points to 3.16%. In the same period the interest rate on new loans to households for consumption decreased by 9 basis points to 7.58%.

As regards new deposits from households, the interest rate on deposits with an agreed maturity of up to one year decreased by 13 basis points to 2.61%. The rate on deposits redeemable at three months' notice stayed constant at 1.74%. The interest rate on overnight deposits from households remained broadly unchanged at 0.35%.

Notes:

- In this press release "corporations" refers to non-financial corporations (sector S.11 in the European System of Accounts 2010, or ESA 2010), "households" refers to households and non-profit institutions serving households (ESA 2010 sectors S.14 and S.15) and "banks" refers to monetary financial institutions except central banks and money market funds (ESA 2010 sector S.122).
- The composite cost-of-borrowing indicators are described in the article entitled "Assessing the retail bank interest rate pass-through in the euro area at times of financial fragmentation" in the August 2013 issue of the ECB's Monthly Bulletin (see Box 1). For these indicators, a weighting scheme based on the 24-month moving averages of new business volumes has been applied, in order to filter out excessive monthly volatility. For this reason the developments in the composite cost of borrowing indicators in both tables cannot be explained by the month-on-month changes in the displayed subcomponents. Furthermore, the table on bank interest rates for corporations presents a subset of the series used in the calculation of the cost of borrowing indicator.
- Interest rates on new business are weighted by the size of the individual agreements. This is done both by the reporting agents and when the national and euro area averages are computed. Thus changes in average euro area interest rates for new business reflect, in addition to changes in interest rates, changes in the weights of individual countries' new business for the instrument categories concerned. The "interest rate effect" and the "weight effect" presented in this press release are derived from the Bennet index, which allows month-on-month developments in euro area aggregate rates resulting from changes in individual country rates (the "interest rate effect") to be disentangled from those caused by changes in the weights of individual countries' contributions (the "weight effect"). Owing to rounding, the combined "interest rate effect" and the "weight effect" and the "weight effect" may not add up to the month-on-month developments in euro area aggregate rates.
- In addition to monthly euro area bank interest rate statistics for November 2024, this press release incorporates
 revisions to data for previous periods. Hyperlinks in the main body of the press release lead to data that may change
 with subsequent releases as a result of revisions. Unless otherwise indicated, these euro area statistics cover the EU
 Member States that had adopted the euro at the time to which the data relate.
- As of reference period December 2014, the sector classification applied to bank interest rates statistics is based on the European System of Accounts 2010 (ESA 2010). In accordance with the ESA 2010 classification and as opposed to ESA 95, the non-financial corporations sector (S.11) now excludes holding companies not engaged in management and similar captive financial institutions.
